Responsible Conduct of Research Modules

Old Dominion University trains all graduate students in the fundamentals of Responsible Conduct of Research (RCR). Graduate students must complete the CITI training prior to completion of 12 semester hours at ODU. GPIS students are required to complete the following modules:

- Misconduct (falsification, fabrication, and plagiarism);
- Data acquisition, management, sharing and ownership;
- Mentor/trainee relationships;
- Publication practice and responsible authorship;
- Peer review;
- Conflicts of interest; and
- Collaborative research.

Students who have not completed these modules will be unable to register for the following semester classes!

The Add/Drop Deadline has passed: All MA students must register for courses at the 700 level and all Ph.D. students must AL-WAYS register at the 800 level.

Spring 2022 Thesis and Dissertation Workshops

The Thesis and Dissertation Workshops are required for Ph.D. students and MA students pursuing a thesis to graduate.

February 8 (12.30pm-1.30pm) February 9 (6pm-7pm) February 10 (12.30pm-1.30pm)

Students should plan to attend a workshop at least one semester before submitting the thesis or dissertation to the Associate Dean's Office.

Spring 2021 thesis and dissertation style editing workshops are scheduled for the dates below. All workshops will be held on Zoom and are scheduled at varying times to accommodate various schedules. Students who intend to complete a thesis or dissertation must attend a workshop at least one semester prior to gradua-

April 1: Dissertations and theses must be submitted electronically for review by the Arts and Letters style editors. Submit the dissertation/thesis and D5/ M3 form to Cathleen Rhodes by completing the form at http://bit.ly/submitoduthesis.

April 25: All formatting corrections required by the style editor must be completed by this date.

*Note: When any date listed above falls on a weekend, the deadline is the following Monday.


In response to challenges in tracking the number of students seeking graduate certificates, ODU has created a new form for degree-seeking students to declare a graduate certificate. Below is more information to share

with your degree-seeking students for them to declare a certificate.

Graduate Certificate Declaration Form Workflow

- 1. <u>1. Student completes the form</u>
- Form is automatically submitted to Graduate Admissions when the student finishes it.
- 3. Admissions will contact the Certificate Coordinator to seek a review.
- 4. Certificate Coordinator reviews student information to determine admission into the program (ideally within 1-2 days).
- Certificate Coordinator sends admission decision to Graduate Admissions.
- 6. If admitted, the certificate program will then be placed in the drop-down Degree tab in Degree Works for the student's file.
- 7. Graduate Admissions notifies student of decision.

M1 - Appointment or Change of Master's Thesis Committee

Form M1 is used to form the committee between the student and his or her advisor or advisory committee. This form should be signed by the student, the faculty advisor, and the Graduate Program Director. If the faculty advisor changes, a new Form M1 should be filed.

<u>M2 - Results of Master's Examination or Requirement</u>

Form M2 is used to document the transition points as the student progresses toward the degree. At each succeeding transition point, the form is updated, and a copy sent to the University Registrar and noted on the student file. The last transition point is the successful completion of the Thesis Defense. At that time, the thesis committee chair signs the form indicating successful completion of the thesis, and the form is also signed by the Committee members.

<u>M3 - Master's Thesis and Acceptance Processing</u>

Form M3 committee chair signs the form indicating successful completion of the thesis, and the form is also signed by the Committee members. Form M3 confirms that the student has submitted the thesis document in its final form approved by the thesis committee. This form must be approved by the Thesis Chair before it goes to the Graduate Program Director. After the Dean's office approves the final thesis and signs Form M3, the student submits the thesis electronically and Form M3 is sent to the University Registrar, with copies to the GPD.

M4 - Notification of a Master's Student Holding an Assistantship in the Final Semester of Study

Form M4 is used to show that the student in his/her last semester of enrollment for the Master's Degree, holds a graduate assistantship, and is currently pending for graduation. The student meets the eligibility requirements and is approved to register for less than nine graduate credit hours. The M4 form is signed by the faculty advisor and the Graduate Program Director.

<u>D1 – Appointment of Doctoral Advising</u> Committee

Form D1 is used to form the committee between the student and their advisor or advisory committee. This form should be signed by the student, the faculty advisor, and the Graduate Program Director. If the faculty advisor changes, a new Form D1 should be filed.

<u>D2 – Appointment of Doctoral Dissertation</u> Committee

Form D2 establishes the committee that will guide a student through the dissertation proposal and defense. The dissertation committee must be tablished prior to the oral defense of the proposal. This form is completed by the student and signed by each member of the committee. It is then signed by the GPD, the Department Chair, and the Dean. The Dean's office has the responsibility to return the original to the GPD, along with electronic copies sent to the Dissertation Chair and the student. A new form D2 must be filed if any member of the committee changes.

<u>D3 – Result of Doctoral Examination or</u> <u>Requirement</u>

Form D3 is used to document the transition points as the student progresses toward the degree. At each succeeding transition point, the form is updated, and a copy sent to the University Registrar and noted on the student file. The last transition point is the successful completion of the Dissertation Defense. At that time, the dissertation committee chair signs the form indicating successful completion of the dissertation, and the form is also signed by the Committee members.

<u>D4 – Doctoral Candidates</u> 1-Hour Full Time

Form D4 confirms the student understands as a doctoral candidate they must register for at least one credit each semester up to and including the semester in which they graduate. The word "full-time" in the sentence "This confirms that the student above has advanced to Doctoral Candidacy Status and is working full-time to complete the dissertation" reflects the fact only one dissertation credit per semester is required to be considered a full-time student once all other requirements have been completed. This form must be completed each semester if the student is receiving financial aid.

<u>D5 – Doctoral Dissertation Acceptance and</u> <u>Processing</u>

Form D5 confirms the student has submitted the dissertation document in its final form Program Director. After the Dean's office approves the final dissertation and signs Form D5, the student submits the dissertation electronically and Form D5 is sent to the University Registrar, with copies to approved by the dissertation committee. This form must be approved by the Dissertation Chair before it goes to the Graduate the GPD.

<u>D7 – Leave of Absence from</u> <u>Doctoral Program</u>

Students are expected to be enrolled in each Fall, Spring and Summer semesters when students have begun dissertation work. A student who finds it necessary to be excused from registration for a semester must report formally before the beginning of the semester to request by petition a leave of absence. The Ph.D. program committee will review the request and decide whether to approve it. The leave of absence may not exceed one year and may not be repeated. The granting of a leave of absence does not change the candidate's responsibility for meeting the deadline for the completion of degree requirements. Leave will be granted only under exceptional circumstances.

D9 – Advancement to Candidacy

The D9 form confirms the student has successfully completed the all the requirements and meets the criteria for advancement to candidacy. This form should be signed by the student, the dissertation Chair, and the Graduate Program Director.



The College of Arts and Letters Style Editors are offering one-on-one Zoom sessions with graduate students preparing a thesis or dissertation and nearing graduation. Students will meet with a style editor who will address the student's specific concerns and/or review a draft of the thesis or dissertation and provide a list of formatting issues to be addressed. These 30-minute sessions are designed to

- help troubleshoot particular style editing problems;
- provide technical and word processing assistance for formatting tables of contents, appendices, landscape pages, and other common problem areas;
- provide feedback on thesis/dissertation drafts to facilitate the formal style editing process.

2022 Graduate Research Achievement Day

The Graduate School will host the 12th annual (3rd Virtual) Graduate Research Achievement Day (GRAD) Competition during Graduate Student Appreciation Week. The weeks spans April 4 to April 8, 2022. I ask your assistance in encouraging students to participate. GRAD is a great opportunity for students to showcase their research to the campus community while learning about the diversity of research and scholarship at Old Dominion University.

GRAD 2022 is a virtual event. Students interested in participating must submit a poster proposal that consists of the graduate student's name, any co-authors, a project title, and a 300-word maximum abstract. The proposal must be submitted no later than Friday, February 28, 2022, at 5:00 p.m. to https://digitalcommons.odu.edu/graduateschool_achievementday2022/. Proposals that do not follow the formatting requirements or are submitted late run the risk of not being accepted.

A committee appointed by the Graduate School will review each proposal and accept those to be included. Students with accepted proposals will be notified by Friday, March 11, 2022.

Those selected to be presented during GRAD will follow the guidelines below:

- Prepare a final abstract with a 300-word maximum that is free of external graphics. It will be placed in ODU Digital Commons, our institutional repository (see last year's posters).
- Prepare a digital E-Poster in PowerPoint or PDF format (up to 3mb) that we can upload into Microsoft TEAMS for judging and then into ODU Digital Commons. (A template that you can use is attached.)
- Submit a zip file containing any additional images, videos, or other media that to include on the Digital Commons GRAD poster page (optional). If possible, we additionally ask that a voice recording of each poster be supplied to increase the poster's accessibility.
- Ensure their E-Posters are received in the correct format by the deadline for judging between April 4th and April 8th. Results and feedback will be available by April 18th. Be sure to obtain faculty permission for all language and data included on and with your poster. If you have sensitive data or privacy concerns, let me know. By submitting your poster, you agree to have it placed in ODU Digital Commons where it will be available openly on the Internet. You also confirm that you and your co-authors hold the copyright or have the approval of the copyright holder and that the work does not infringe any copyright.

Let us work together and show everyone the outstanding research and scholarship taking place at Old Dominion University! Thank you for your support!





GSIS and GPIS are pleased to announce the **Keynote Speaker for the Luncheon** at the 20th Annual Graduate Research Conference will be **Dr. Simon Serfaty**

He began his academic career at the University of California in Los Angeles (UCLA) in 1968, where he was soon named Political Science Teacher of the Year. After 20-some years at the Johns Hopkins School of Advanced International Studies (SAIS) in Washington, DC, he joined Old Dominion University in September 1992 and retired in June 2020 as Professor and Eminent Scholar Emeritus, with the Faculty Recognition Award for his contributions to the academic, professional, and personal success of students during his final Spring semester. Over the years, he led the Johns Hopkins Center of European Studies in Bologna, Italy, the Johns Hopkins Foreign Policy Institute (FPI) at SAIS, and the European Program at the Center for Strategic & International Studies (CSIS), where he was named the first Zbigniew Brzezinski Chair in Geostrategy and Security Studies (now emeritus). He has also served in a variety of other think tanks such as German Marshall Fund, the Institut Français de Relations Internationales (IFRI), the Rome-based Istituto of Affari Internazionali (IAI), the Brussels-based Transatlantic Policy Network (TPN). A naturalized US citizen (1965) born in Casablanca, Morocco, Serfaty was named (2008) Knight of the Legion of Honor, France's highest civilian honor.
