Instructional Space Subcommittee

Recommendation Formulations

- 1. Increase infrastructure capacity for experiential learning building partnerships with local business/industry to use off-campus, privately owned space for learning/instruction.
 - Are there accreditation issues?
- 2. Move to a 3-semester scheduling model to even out course offerings and faculty work load
 - Changes business model
 - Would existing infrastructure support this as a model for expanding instructional capacity?
