Parking Citation Appeals


- Only accepted online via the parking portal
- Must be filed within 7 days of the parking citation
- Usually responded within 14 days of appeal

Parking Citation Re-Appeals

- Must be filed within 14 days of appeal result
- Require payment of fine to file
- Reviewed by Parking Citation Re-Appeal Committee










FY23 Year to Date Appeals





Immobilization (Boots)


- Three unpaid parking citations
- Total value exceed \$100 in unpaid citations
- Minimum 30 days since the oldest citation
- Automated query that leads to an LPR hotlist
- Additional \$40 fee (boot removal fee) added to the citation
- Seventy-Seven (77) immobilized vehicles this Fiscal Year





Towing

- Parking in a designated Reserved Parking space (including football, basketball, and special event parking)
- Illegally parked in a space reserved for disabled
- Abandoned or inoperable vehicle
- No Parking Zone
- Blocking Traffic or in a Fire Lane / Safety Reasons
- Excessive Unpaid Citations
- This year towed fourteen (14) vehicles off-campus






TPS Towing Operator: Affordable Towing & Recovery
