## **Graduate Pass/Fail**

Master's-level students may include pass/fail-graded courses, to fulfill a portion of their program requirements provided that at least 18 hours are letter-graded course work (which does not include pass/fail courses), and any additional departmental or school requirements are satisfied. The college, school, and/or department administering the program shall determine which student course work shall be eligible for pass/fail credit.

Doctoral students must take dissertation credits as pass/fail. They may also select from among the designated pass/fail-graded experiences to meet their program requirements. They must take a minimum of 24 credit hours of letter-graded course work beyond the bachelor's degree and meet any additional departmental or school requirements.

For courses that permit a pass/fail grading modality, students may elect to add or change such a course to or from pass/fail, during the "add/drop" period only.
