All states require the completion of supervised predoctoral practicum hours and a predoctoral internship. These aspects are also required for the doctoral degree in clinical psychology at Old Dominion University. In addition to education requirements for the doctoral degree, however, many jurisdictions require post-doctoral professional experience. Note that in some jurisdictions, in addition to being licensed as a psychologist, an individual can obtain prescribing privileges. The ODU Ph.D. Program in Clinical Psychology does NOT fulfill requirements for licensure as prescribing psychologists in those states and jurisdictions that allow for it. Typically, additional coursework in pharmacology is needed in addition to the doctoral degree. Please see the ASBPP website for information about other U.S. territories and Canadian provinces.

The ODU PhD in Psychology Clinical Concentration is not yet accredited by the American Psychological Association (APA). ODU has led the administration of the APA-accredited Virginia Consortium Program in Clinical Psychology and has been training doctoral students in clinical psychology for over 43 years. The ODU Clinical PhD program applied for APA accreditation as a clinical psychology PhD program independent of the Consortium in Summer 2025, with a site visit anticipated in Fall 2026. Although the timeline and application outcome cannot be assured, we hope to receive APA Accreditation on Contingency in Spring 2027. Because our program has been designed to match the current APA accreditation and licensure requirements, the ODU PhD Clinical program curriculum matches the requirements of the state educational requirements for licensure as noted below.
