Refining Our Learning Goals

The Steering Committee reviewed the Working Group reports, identified the most common themes, and proposed these five broad learning goals:

- Inquiry and Research
- Reasoning and Problem-Solving
- Civic Engagement and Social Responsibility
- Communication and Expression
- Reflection and Lifelong Learning

We shared these goals with Faculty Senate, who appreciated the steps taken this year and supported our plan for the next phase of the reform process.

April Accomplishments

- April 5: Working Groups submitted reports
- April 7: Steering Committee met to begin drafting broad learning goals for the new general education program.
- **April 14:** Steering Committee met to refine the draft learning goals.
- April 18: General Education Reform Full Team met to provide feedback on the draft learning goals.
- April 18: Faculty Senate Committee A reviewed the draft learning goals and provided feedback.
- April 21: Steering Committee heard
 Committee A feedback and refined learning goals.
- April 22: The draft learning goals were presented to Faculty Senate for input.

Looking Ahead...

In mid-May, Faculty and Operations Committees will meet for a full team retreat to onboard additional members and begin planning for the coming year's work. AY 25/26 tasks include: recommending curriculum revisions, developing learning outcomes, exploring possible frameworks and requirements, and proposing solutions to address the challenges identified by external reviewers.

Year 4 (AY 26/27): Goal: Pilot, Assess, Refine, and Seek Full Faculty Senate Approval

Year 5 (AY 27/28): Goal: Faculty and Course Development, Catalog and Schedule Revisions
