PrEP

Pre-Exposure Prophylaxis (PrEP) is medication taken every day to reduce to the risk of sexually acquired HIV in adults. <u>Truvada</u> is the brand-name of the medication. Truvada was approved by the Food and Drug Administration (FDA) for use in combination with safe sex practices for those who are HIV-negative.

PrEP is effective when **taken every day** AND **active risk-reduction behaviors are used**. Active risk-reduction behaviors include using condoms 100% correctly for each sexual encounter, knowing your partner's HIV status, and reducing the number of partners.

Prescriptions for PrEP can be filled through a pharmacy.

Who should consider taking PrEP?

PrEP is for people who do not have HIV and who are at high risk for getting HIV from sexual activity or from injecting drugs.

PrEP Appointments

PrEP can only be prescribed by a healthcare provider. Students interested in learning more about PrEP or being prescribed Truvada can schedule an appointment with Student Health Services (757-683-3132).

First Visit

- Call or stop by to schedule an appointment.
- Your first appointment is about one hour long.
- Arrive 15 minutes before your appointment time to complete the check-in process.
- Have a list of your current medications or bring them with you.
- Do not urinate one hour prior to the appointment. You should be prepared to provide a urine sample.
- Be prepared to have lab testing (blood draw), including a lab test for HIV and other tests.
- During your visit, your healthcare provider will conduct a thorough review of your medical and sexual health history. You will be asked about your medications and symptoms of acute HIV infection.
- If needed, vaccines may be administered or recommended.

• You will receive information at your appointment about PrEP, safer sex, options for uninsured patients and cost information.

Preparing for your first visit

PrEP is a **commitment**. It must be taken every day. Consider strategies to adhere to a daily medication, now, before committing to PrEP.

PrEP is a medication which means it may have side effects, cannot be taken with some medications (interaction profile), and may have adverse effects. Ask your healthcare provider about side effects and how you should respond to any side effects.

Consider the cost of Truvada and PrEP follow-up appointments. There may be costs for the medication, lab tests – including an HIV test every 3 months, and possible other fees, such as for vaccinations. Contact your health insurance company regarding costs and your plan. There may be options available to you if you do not have health insurance.

Follow-up appointments

After the first appointment, if you begin taking PrEP, you will need to schedule regular follow-up appointments.

- 3 7 days
- At 3 weeks
- At 2 months
- At least every 3 months while taking PrEP. Your HIV status will be tested every 3 months.
